Some background

Founded in 1985, West Cork Arts Centre celebrates its 40th birthday and the 10th anniversary of its move to a permanent, purpose-build home at Uillinn in 2025.

Our two main galleries house contemporary art exhibitions that intrigue and inspire, presenting artwork by local, national and international artists and a Gallery Programme of guided tours, gallery talks and free resources such as the Discovery Box for families.

The three Artists' Studios provide space for Irish and international artists to work on site and to meet the public, and the Dance Residency brings top-class contemporary dancers, choreographers, performers and musicians to Uillinn to develop new work and present it to the public throughout the year.

The vibrant and diverse participation programme enriches the visitor experience through workshops, masterclasses, film screenings, and dance and discussion platforms, and encourages equality of access for people of all ages and cultures through its long-term programmes and projects.
